Terms and Conditions of Use

By using the Online Traffic Crash Report Service (“Service”) you agree to the following applicable terms and conditions of use, as they may be amended from time to time. If you use this site, you are responsible for restricting access to your computer, and you agree to accept responsibility for all activities that occur from your computer. If you believe that access has been lost or stolen or that someone may attempt to use your account without your permission, you must notify the Plano Police Department Records Unit at once by calling 972-941-2019.

Payment Authorization

By providing the Service with your credit card account information, you authorize the Service to follow your payment instructions and to debit or charge your credit card in the amount indicated in your payment instructions. The City of Plano and its affiliates reserve the right to suspend or refuse service, terminate accounts, block or terminate payment activity, remove or edit content, or cancel transactions at their sole discretions. Neither the termination nor suspension of your use of this Service shall affect your liability or obligations for timely payment of your fees.

Liability for Returned Payments

In the event your online payment is not processed or authorized by your credit card company or financial institution, your liability to the City of Plano will not change. The City will not accept liability for a payment not processed, refused, or declined by the credit card supplier. You must verify with your credit card company that the payment is processed.

Online Refund Policy

In accordance with the City of Plano Policy #204 Refunds and Adjustments, in the event that your credit card was charged in error, requests for refunds or adjustments should be made within thirty (30) days of the original transaction processing date. We reserve the right to revise this policy at any time.

Other Legal Terms and Conditions

The City of Plano reserves the right to change this Service (including terminating the Online Traffic Crash Report Service) and these Terms and Conditions of Use, in our sole discretion and at any time, without notice to you except as required by applicable law. The Service shall not be deemed to have waived any of its rights or remedies hereunder unless such waiver is in writing and signed by and authorized representative of the City of Plano.
